Classes: Sincere Studio held roughly 300 classes in 2024. Between classes, clubs and open studio hours, we had 1,193 participants. Our Intro to Sewing classes served 443 students. In addition to our paid signups, we offered free classes and sliding-scale signups to increase accessibility.

Part and Line Number: **Part III - Line 29**

Our affinity groups offer free three hour blocks of open studio time to anyone who would like to attend. These clubs have become a staple of the Sincere Studio community and have fostered and strengthened new relationships between participants. Sincere Studio's BIPOC Sewing Club had 111 signups over 24 meetings. The Queer & Trans Sewing Club had 121 signups over 24 meetings. We also host a quilt guild which met 6 times and had 38 signups.
